



## Veloxis Increases Share Capital in Connection with Exercise of Warrants

### Veloxis Increases Share Capital in Connection with Exercise of Warrants

Veloxis Pharmaceuticals A/S announces that the Company's capital has been increased by 1,104,523 new shares with a nominal value of DKK 0.10 each corresponding to an increase of the share capital with nominally DKK 110,452.30 as a consequence of the exercise of warrants by current and former employees of the Company granted under the Company's warrant program.

As a result of the employee's investment in the Company proceeds to Veloxis Pharmaceuticals A/S from the capital increase amount to DKK 1,228,630.52.

The subscription price for the new shares is DKK 0.86 per share of nominal DKK 0.10 (with regard to 283,332 shares), DKK 0.95 per share of nominal DKK 0.10 (with regard to 300,000 shares), DKK 1.01 per share of nominal DKK 0.10 (with regard to 224,582 shares), DKK 1.06 per share of nominal DKK 0.10 (with regard to 100,000 shares), DKK 1.12 per share of nominal DKK 0.10 (with regard to 44,444 shares), DKK 2.06 per share of nominal DKK 0.10 (with regard to 122,165 shares), and DKK 2.19 per share of nominal DKK 0.10 (with regard to 30,000 shares).

The new shares will be listed on NASDAQ Copenhagen following registration of the capital increase with the Danish Business Authority, upon which the share capital of Veloxis Pharmaceuticals A/S will be DKK 173,943,534 divided into shares of DKK 0.10 each.

Each share of nominal DKK 0.10 carries one vote at general meetings in Veloxis Pharmaceuticals A/S. The new shares give rights to dividend and other rights from the time of registration of the capital increase with the Danish Business Authority.
